Only those who have purchased the Bidding Documents until 12NN of the day before the pre-bidding conference shall be sent invitation to participate in the pre-bidding conference and raise or submit written queries or clarifications. However, bidding documents shall still be available for purchase after the pre-bidding conference. Deadline for purchase of bidding documents is 5 days before the bid opening date.

All Bid Proposals shall be accepted at the BAC Office two (2) hours before the scheduled bid opening conferences, otherwise, shall be disqualified.
